**Provision of Web Security Solution**

The Police and Crime Commissioner (PCC) for Derbyshire Constabulary currently has a Contract in place for the provision of Web Security Solution with Insight Direct (UK) Limited (sub-contracted to Forcepoint) of which is due to expire on 24 December 2022.

We looked to procure a replacement product to the current solution, with consideration of Derbyshire Constabulary's recently procured WAN replacement to an SD-WAN solution (VMware) that is due to go live in May 2023, as well as incorporating additional features with an evolving web security landscape.

Derbyshire Constabulary aimed to enhance the organisational security posture with ever increasing web-based threats, driven by the migration of on premise to cloud-based solutions.

A route to market has been identified via the Derbyshire IT Hardware, Software and Consumables framework which is in place with Insight Direct (UK) Limited as it offers a compliant route to market via direct award.

The business requirements were shared with Insight Direct (UK) Limited, and the proposals were reviewed by IS and Procurement. A viable solution, offered by FortiNet, has been evaluated and meets the business requirements and therefore the contract for the Provision of a Web Security Solution is to be awarded to Insight Direct (UK) Limited (of which will be provided by FortiNet) for the total contract value of £130,690.74. This is to be paid in Year 1 of the Contract and covers the full 5 years of the Contract.
