Safespace

The Police and Crime Commissioner for Derbyshire wanted to establish a single Provider Contract for the Provision of a Safe Space within Derby City. The service will operate 24 hours a day, 7 days a week and 365 days a year and will be known as Safe Space in Derby City. The service will provide services to meet basic human needs of shelter, water and refreshment, sanitation and safety for rough sleepers, those at imminent high risk of rough sleeping and those who repeatedly struggle to maintain any accommodation through multiple complexities and high levels of need. In November 2021, a review of the Safe Space Project and model was completed. Contributions from, and interviews with, over twenty different teams and agencies combined with analysis of a wide range of local data collected by key agencies over the past two and half years draw the conclusion that the investment made in Safe Space is currently returning at least three times the Partnership investment value each year in measurable cost savings.

14 suppliers expressed their interest, and one bid was received from Derby City Mission. Derby City Mission are the incumbent provider and following on from an open tender process they are the winning bidder. The full Contract value of the service will be £717,898.50 Due to the funding arrangements, Derby City Mission will be providing a contribution of £45,000 over the full term of the Contract.

The Contract will commence on 17 October 2022, with an expected service Go Live date of 15 January 2023, and will expire on 31 March 2025. The total value of the Contract is £717,898.50 which covers the full-term of the agreement.
