October 2022-February 2023 – Average waiting time of 39 days.

The Commissioner leads a multi-agency funded Children and Young People's Independent Sexual Violence Advisor (ChISVA) service for young sexual abuse victims at all risk levels in Derbyshire.

Independent Sexual Violence Advisers (ISVAs) provide continuous support, advice and help for victims and survivors of sexual violence.

ChISVAs provide all or some of the following:

- practical and emotional support to anyone aged 5-18 years who have experienced rape, sexual abuse, or sexual exploitation at any time in their life.
- help explain the criminal justice system and provide support throughout the process. ChISVAs talk through options to allow for an informed decision to be made about whether to report to the police. If the choice is made to report to the police, the ChISVA will support the young person through this process.
- advocate for the young person, to ensure their voice is heard, their needs are met, and that they are listened to and believed, during what is a difficult time. They will also help the young person to understand what is being said to them by other agencies such as the police.
- offer independent sexual violence advocacy to the supporters of survivors, most commonly parents, partners, and family members.
- impartial information to the victim/survivor about all of their options, such as reporting to the police, accessing CYP Sexual Assault Referral Centre (SARC) services, and specialist support such as pre-trial therapy and sexual abuse counselling. ChISVAs also provide information on other services that victims/survivors may require, for example in relation to health and social care, housing, or benefits. The benefit of the ChISVA role is to provide ongoing continuity and impartial advice and information to a victim/survivor of sexual violence.
