I write in connection with your request for information processed under the Freedom of Information Act 2000 and received in the Office of the Police and Crime Commissioner for Derbyshire on 25/10/2023 when you asked the following question(s):

What is the Police and Crime Commissioner currently doing to combat knife crime?

Please supply details of current initiatives.

I can confirm that the Office of the Police and Crime Commissioner for Derbyshire holds the information that you have asked for.

In answer to your request please see the following:

"In January this year, the Commissioner secured funding from the Home Office worth more than £1million to tackle serious violence, including knife crime, until March 2025. This funding has been used to create Derbyshire's first ever Violence Reduction Unit (VRU) to address the root causes of serious violence and prevent further offending.

In addition to the newly created VRU, the Commissioner's office has funded over £160,000 worth of interventions aimed at preventing serious violence offending, which includes knife crime, across Derby and Derbyshire. These measures began earlier in summer and include intensive mentoring support for young people identified as either at risk of involvement in violence or who have committed a violent act/offence. A specific programme aimed at addressing conflict/aggression within families and education and awareness workshops which are to be delivered in schools and colleges."

What has been spent (£) on these initiatives? Please supply figures for the past five years (calendar or financial) -- from 2018 to the present.
