- 7. Full names of the custody Police Officers, PC numbers, address, indemnity insurance on duty 10/11/2023, there personal video/camera footage;
- 8. Full names of the assaulting Officers, PC numbers, address, indemnity insurance, personal video/camera footage,
- 9. Video/camera footage of assault by Police Officers from the holding Police custody cell:
- 10. Video/camera footage of torture by Police Officers from the fingerprinting room;

Please provide the information in the form a PDF or word document.

If you are not satisfied with our response to your request, under Section 17 of the FOIA you are entitled to ask for an internal review of our decision. Any internal review needs to be submitted within two months of the date of receipt of this response and state why you are unhappy with the response.
