I write in connection with your request for information received in the Office of the Police and Crime Commissioner for Derbyshire on the 1st October 2025. You asked the following questions:

"I am writing to request information under the Freedom of Information Act 2000.

I would like to request the following details regarding planned or anticipated procurement activities for the period October 2025 to September 2027:

- 1. Any planned tenders or procurement exercises for security systems, fire alarm systems, and CCTV systems, including installation, maintenance, and monitoring services:
 - a. Digital/Smart Buildings Platform
 - b. Fire Alarms
 - c. Fire Suppression
 - d. Access Control
 - e. Intruder Alarms
 - f. CCTV
 - h. Affray Alarms
 - I. Cell Call/ Care Comm
- 2. Estimated timelines for issuing these tenders.
- 3. Expected scope and value of the contracts
- 4. Any pre-market engagement or supplier briefing events scheduled
- 5. Contact details for the relevant procurement or facilities teams managing these tenders.

If available, please provide the information in electronic format (PDF, Excel, or Word). If any part of this request requires clarification, I would be happy to assist.

I understand that under the Act, I am entitled to a response within 20 working days. If any of the requested information is exempt from disclosure, please specify the relevant exemption and provide reasoning."

This is to inform you that the Office of the Police and Crime Commissioner for Derbyshire does not hold the information you have requested based on the information you have provided.

Derbyshire Constabulary may hold this information and I give below a link to the Force's website where you can make a FOI request to them direct.

If you are not satisfied with our response to your request, under Section 17 of the FOIA of the FOIA you are entitled to ask for an internal review of our decision. Any internal review needs to be submitted within two months of the date of receipt of this response and state why you are unhappy with the response.
