## FOI Request: 34/2025

I write in connection with your request for information received in the Office of the Police and Crime Commissioner for Derbyshire on the 6<sup>th</sup> November 2025. You asked the following questions:

"Please supply me with the numbers annually from and including 2017 to the current date of those arrested under Section 136 of the Mental Health Act 1983 officers of Derbyshire Constabulary and taken to a health-based place of safety operated by Derbyshire NHS Healthcare Foundation Trust. The numbers of those taken by the police to the Radbourne Unit, Royal Derby Hospital, would suffice if that information is readily available.

Of those occasions, how many related to incidents recorded as:

a. A person believed to be suicidal or attempting to take their own life; b. A person recovered from a bridge, motorway overpass, or other elevated structure." If this information is not held in structured form, please advise whether the incident recording system includes flags, tags, or categories that might approximate to these descriptions."

This is to inform you that the Office of the Police and Crime Commissioner for Derbyshire does not hold the information you have requested based on the information you have provided.

Derbyshire Constabulary may hold this information and I give below a link to the Force's website where you can make a FOI request to them direct.

## I want to find information about the police | Derbyshire Constabulary

If you are not satisfied with our response to your request, under Section 17 of the FOIA of the FOIA you are entitled to ask for an internal review of our decision. Any internal review needs to be submitted within two months of the date of receipt of this response and state why you are unhappy with the response. You can submit an internal review in the following ways:
