Provision of Restorative Justice Services

The Police and Crime Commissioner for Derbyshire wanted to establish a Restorative Justice Service in Derbyshire (to include Derby City), for all Adults and Young People, which is compliant with the MOJ Victims' Code of Practice for England and Wales and the Restorative Justice Council's Restorative Services Standards and Quality Mark. The provision will aim to increase the well-being and safety of Victims and their families in Derbyshire, by providing a good quality, safe and competent victim-lead Restorative Justice Service. The Service will be available at all appropriate points throughout the criminal justice process – pre and post sentence – and will be victim-centred, enabling victims to cope and recover as part of the Commissioner's other suite of Victims' Services. The current contract is due to expire on 31 March 2023, therefore an Open Tender process was conducted to procure the Service. 12 suppliers expressed an interest in the tender and two bids were received. The tender was evaluated on the Most Economically Advantageous Tender (M.E.A.T) which was split between 95% quality and 5% price.

Remedi - Restorative Services were awarded 95% for their quality submission, and 5% for their price submission and are therefore the winning bidder.

The total value of the contract is £699,755.00 which covers the initial Contract Period of 3 years, with the option to extend for a further 2 x 12 months.
