**ISVA Contract**

The Police and Crime Commissioner for Derbyshire, Derbyshire County Council and Derby City Council wanted to establish an Independent Sexual Violence Advisor Service for sexual abuse victims at all risk levels in Derbyshire inclusive of Derby City. The Provider will deliver an evidence-based support service within Derby and Derbyshire that meets the needs of Victims and that can demonstrate co-operation with a range of organisations and partners in the City and County including the other services forming the PCC's CoRe victims offer. This will include a range of statutory agencies such as the Councils, the Police and Health Organisations and a range of other support services. The Provider will also need to demonstrate close working relationships with other voluntary bodies especially other providers of Sexual Abuse Services.

10 suppliers expressed an interest in the tender and one bid was received from SV2 – Supporting Victims of Sexual Violence Limited. SV2 are the incumbent provider and following from an open tender process they are the winning bidder. The Provision is jointly funded by the Police and Crime Commissioner for Derbyshire, Derbyshire County Council and Derby City Council using a partnership agreement. The PCC will contribute £350,000.00, Derbyshire County Council will contribute £200,000.00 and Derby City Council will contribute £120,000.00 for the first three years, further funding will be discussed upon Contract extension. Therefore, the total value of the contract is £750,000.00 which covers the initial contract period of 3 years with the option to extend for a further 24 months.
