### DP0843 BSL 101 App

In 2022 Derbyshire introduced the new 999 BSL service which is a service that connects a person to the Contact Management Centre, via a British Sign Language (BSL) Interpreter remotely through an app or a web-based platform. This was seen as a huge step forward in ensuring that all our Derbyshire's communities have access to Derbyshire Constabulary. Whilst this service has improved the ability for contact, there is no option outside to contact 101 with a non-emergency. Deaf BSL users are expected to utilise email or text messaging. By introducing SignVideo App, this creates a shortcut on our website and allows Deaf BSL users to click a link which creates a call through to the Control Room as a 101 call. The call can then be dealt with in the same way as any other 101 call. In addition, the SignVideo App can be deployed onto officers MDT's and Desktops/Laptops.

The App does not replace the Big Word service in custody or Cintra for interviews and formal statements. But it will facilitate day to day contact in the community, and at urgent times of need.

Funding has been granted through a recent business case.

The route to market is via Single Tender Approval. The STA was progressed and signed off by the OPCC on 10 January 2024.

The Contract covers the period of 3 years from 03 January 2024 with a total contract value of £30,250.
