Aerial Mast Managed Service

This Framework Agreement is for income generation from the Aerial Masts Rentals, which was advertised over 2 Lots (Lot 1 – Derbyshire Constabulary, Northamptonshire Police and Nottinghamshire Police. Lot 2 – Leicestershire Police) The consultant manages the Aerial Masts for each force within the Lot and takes an agreed commission % from managing the rent roll income from the mast operators. The current contracts are due to expire on 31st March 2023.

This was a regional collaborative tender and Derbyshire conducted the tender process for 4 forces in the region on behalf of Leicestershire, Nottinghamshire, Northamptonshire and Derbyshire.

There will be a Derbyshire Constabulary Framework in place from 1st April 2023 for four years, with an option to extend for 12 months.

Each force will enter into their own call off contract via the framework order form process.

An open tender process was conducted via Regional collaboration. 9 suppliers expressed an interest in the tender and 2 suppliers submitted a response. All of the responses were evaluated by Estates and Facilities representatives from Derbyshire, Leicestershire and Nottinghamshire and submissions were evaluated on the Most Economically Advantageous Tender (M.E.A.T) which was split between 35% quality and 65% price.

Lot 1 – Batcheller Monkhouse were awarded 35% for their quality submission, and 65% for their price submission and were the successful bidder. Both bidders achieved the same quality score for this lot and Batchellor Monkhouse scored the highest marks for their pricing submission as they tendered the lowest % rate for this

lot.
