Provision of Services for Standard and Medium Risk DA in Derby City

The current agreement with Refuge for the Provision of Services for Standard and Medium Risk Domestic Abuse Victims in Derby City is due to expire on 31 March 2022. This service is being procured and led by the OPCC for Derbyshire. It will be a flexible service providing emotional and practical support to anyone experiencing domestic abuse living in Derby.

The provider will need to deliver an evidence-based support service within Derby City that meets the needs of Derby victims and that can demonstrate co-operation with a range of organisations and partners in the city and county including the other services forming the PCC's CoRe victims offer. This will include a range of statutory agencies such as the councils, the police and health organisations, housing organisations and a range of other accommodation and support services. The provider will also need to demonstrate close working relationships with other voluntary bodies especially other providers of DA services. An open tender was published via the EU Portal and two compliant bids were received which were evaluated against the published criteria of 95% Quality and 5% Price. The quality scoring was further split 70% for the response to the method statements and 25% for presentation.

Refuge have been awarded the contract having been assessed as offering the most economically advantageous tender. The new contract will commence on 1st April 2022 for an initial term of 3 years with the option to extend for a further 2 x 12 months.
