I write in connection with your request for information received in the Office of the Police and Crime Commissioner for Derbyshire on 26 October 2021. You asked the following questions:

Regarding The Royal Derby Hospital, for the time period of 1st January 2019 to 1st September 2022, please supply the following information:

- 1. How many reports have been made to the police about if sexual assaults (excluding rapes) on the above hospital premises?*
- 2. How many of the incidents in respect of 1. above took place on hospital wards?*
- 3. How many people in respect of 1. above were charged?*
- 4. How many people in respect of 1. above were prosecuted?*

- 5. How many reports have been made to the police about of rapes on hospital premises?*
- 6. How many of the incidents in respect of 5. above took place on hospital wards?*
- 7. How many people in respect of 5. above were charged?*
- 8. How many people in respect of 5. above were prosecuted?*

(Please note that these questions have already been answered on appeal by other police forces as the Section 40 (5) (a) Personal Information and Section 30 (3) Investigations and proceedings exemptions were found to be NOT APPLICABLE).

This is to inform you that the Office of the Police and Crime Commissioner for Derbyshire does not hold the information you have requested based on the information you have provided.

Derbyshire Constabulary may hold this information and I give below a link to the Force's website where you can make a FOI request to them direct.

If you are not satisfied with our response to your request, under Section 17 of the FOIA of the FOIA you are entitled to ask for an internal review of our decision. Any internal review needs to be submitted within two months of the date of receipt of this response and state why you are unhappy with the response.
