I write in connection with your request for information received in the Office of the Police and Crime Commissioner for Derbyshire on 28 November 2021. You asked the following questions:

- 1) When did Operation Trek commence?
- 2) Who is in charge of this? How many officers have been involved in it since it was created?
- 3) Please provide a copy of the operations order.
- 4) With whom is it in contact? Has it had working contact with all parties, such as hunters and anti hunt protestors?
- 5) How many arrests and charges have been made in relation to the work of this unit? What crimes were the arrests, or charges, for?
- 6) Please name all the Hunts you have communications with as part of Operation Trek.
- 7) Please supply details of all communications with the Hunts, or anyone associated with this.
- 8) Please name any anti hunt groups you have communications with as part of Operation Trek.
- 9) Please supply details on all communications with anti hunt protestors, or anyone associated with this activity

This is to inform you that the Office of the Police and Crime Commissioner for Derbyshire does not hold the information you have requested based on the information you have provided.

Derbyshire Constabulary may hold this information and I give below a link to the Force's website where you can make a FOI request to them direct.

If you are not satisfied with our response to your request, under Section 17 of the FOIA of the FOIA you are entitled to ask for an internal review of our decision. Any internal review needs to be submitted within two months of the date of receipt of this response and state why you are unhappy with the response.
