I write in connection with your request for information processed under the Freedom of Information Act 2000 and received in the Office of the Police and Crime Commissioner for Derbyshire on 3 December 2019.

In answer to your request please see the following:

1. Derbyshire PCC has awarded 2 x £30,000 extended grants for 2019-2021 (ref May 2019). How will these grants be monitored? (Apart from Al Hurraya's own written report?)

Our monitoring requirements consist of a written activity report and a breakdown of expenditure at six months and twelve months. A meeting will take place between the Commissioning team in the OPCC and Al-Hurraya staff to go through the reports in detail and oversee the progress being made compared to the outcomes agreed with Al-Hurraya in the grant agreement. In addition, Sarah Greensmith has visited the Al-Hurraya office on more than one occasion and has also observed some of the sessions being delivered to the young people in the Mosque.

2. These grants would not be awarded to someone who has not complied with the Proceeds of Crime Act – so has Mr Ashraf paid his debt regarding his criminal benefit of £91,281?

The grant agreement is between the OPCC and AI-Hurraya who employ Mr Ashraf to deliver the project. The OPCC does not pay Mr Ashraf any money directly. The Commissioner has no reason to question Mr Ashraf's ability to deliver the project on behalf of his Employer, AI-Hurraya comply with all of the due diligence checks required by the PCC and has satisfied questions around safeguarding, financial management and delivery programme.

3. The workshop manuals/ teaching plans should be available for perusal – as this would not compromise confidentiality. I am interested in the material used- other companies have produced videos, training material which I have seen and is AI-Hurraya harnessing the benefit of this material incorporating it into their work?

A visit to observe some of the sessions has satisfied the Commissioning Team of the standard and quality of this delivery. Full lesson plans will be made available at the next grant review which will take place in April 2020.

4. Which schools/mosques will be visited?

Full detail for this year's activity and progress will be available in the next six month report in April 2020

5. What is his target population?

6. How will he access appropriate participants?

Any internal review needs to be submitted within two months of the date of receipt of this response and state why you are unhappy with the response.
