Please find our letter dated 27 July 2023, attached setting out the departments obligation in respect of Freedom of Information Act 2000 and 2002 (in the bottom third of the letter) also pursuant to the general rules of disclosure.

Derbyshire Police are obligated at law to provide:

- 1. An update with regard, to the serious hate crimes reported by our client URN:
22000509019, no later than 5pm 4 August 2023.***
- 2. All information held with regard to the 8 separate Crime Reports lodged
with Derbyshire Police, now categorised ‘Serious - Hate Crime URN: 22000509019, no
later than 5 pm 31 August 2023.***
- 3. All information held with regard to the allegations made in respect of our
client including but not limited to her election campaign, no later than 5 pm 31 August
2023.***

***The information provided should include all attendance notes made by each agent of
Derbyshire Police and the records of all meetings. Please provide the information by
electronic/email service to this email address.***

We look forward to your prompt disclosure of the files.”

This is to inform you that the Office of the Police and Crime Commissioner for Derbyshire does not hold the information you have requested based on the information you have provided.

Derbyshire Constabulary may hold this information and I give below a link to the Force’s website where you can make a FOI request to them direct.

If you are not satisfied with our response to your request, under Section 17 of the FOIA of the FOIA you are entitled to ask for an internal review of our decision. Any internal review needs to be submitted within two months of the date of receipt of this response and state why you are unhappy with the response.
