Police and Crime Commissioner for Derbyshire: Auditor's report on the financial statements

We are pleased to be able to advise you that the audit of the Police and Crime Commissioner's financial statements for the year ended 31 March 2025 has been completed and a copy of our auditor's report is attached. Please include this auditor's report in your statement of accounts before publishing it on your website.

We have not issued our certificate of completion of the audit at this time because we cannot formally conclude the audit and issue an audit certificate for the Police and Crime Commissioner for Derbyshire for the year ended 31 March 2025 in accordance with the requirements of the Local Audit and Accountability Act 2014 and the Code of Audit Practice until we have received confirmation from the National Audit Office the audit of the Whole of Government Accounts is complete for the year ended 31 March 2025. We are satisfied that this work does not have a material effect on the financial statements for the year ended 31 March 2025.

Please note that Regulation 16(1) of The Accounts and Audit Regulations 2015 requires the Police and Crime Commissioner to publish (which must include publication on its website) a statement:

- that the audit has been concluded
- that the statement of accounts has been published
- of the rights of inspection conferred in local government electors by section 25 of the Local Audit and Accountability Act 2014 and the address at which, and the hours during which, those rights may be exercised.

As the audit has not yet been concluded, the Police and Crime Commissioner cannot yet issue this statement. We therefore suggest that the Police and Crime Commissioner includes a clear statement on its website to this effect, with a link to the published statement of accounts. The notice of conclusion of the audit should then be added to the website alongside our audit certificate as soon as this is issued.

We have set out below further details regarding the finalisation and publication of the Police and Crime Commissioner's statement of accounts, which includes the audited financial statements.

Auditor's reports on the financial statements

We have noted your wish to publish and distribute the statement of accounts, which includes the financial statements, in electronic format. Please note that:

- the examination of the controls over the electronic publication of audited financial statements is beyond the scope of the audit of the financial statements and the auditor cannot be held responsible for changes made to audited information after the initial publication of the financial statements and auditor's report;
- where you wish to publish or distribute the financial statements electronically (separately or within the statement of accounts), you are responsible for ensuring that the publication accurately presents the financial statements and auditor's report on those financial statements. This responsibility also applies to the presentation of any financial information published in respect of prior periods; and
- the auditor's report on the financial statements should not be reproduced or referred to electronically without our written consent.

Please ensure that:

- you publish the financial statements and the auditor's report on those statements together in the statement of accounts;
- you only publish the financial statements accompanied by the "other information" provided to us before we issued our audit report and specifically referred to in our audit report; and
- you do not publish the financial statements accompanied by any other information not provided to us prior to issuing our auditor's report.

Additionally, please ensure that you do not reproduce the signature of the auditor in any electronic format for any other purpose.
